If I default on my payment(s), the School may refer unpaid balances to a collection agency or litigate to collect payment. I will be responsible for reasonable collection costs, including, for example, attorneys' fees and other necessary charges.
- (4) The School or its agent(s) may disclose that I have defaulted, along with other relevant information, to credit agencies.
- (5) This agreement may be changed only in writing and as signed by an approved School official.
